# Council on 6<sup>th</sup> October recommended the following changes to the Rules & Constitution

### Rules & Constitution (Handbook Page 38)

#### 2 Objects

2A. To promote and safeguard the game of Flat Green Lawn Bowls in Hertfordshire.

#### 4. Membership

4A. Line 2:with members that play the Flat Green game.....

Reason: To bring our wording into line with Bowls England description of our sport.

#### 6. **Officers** (P39)

A Line 4 *after* Match Secretary, *add* Competition Secretary and shall be elected at the Annual General Meeting, with the exception of the County Development Officer who will be appointed by the Executive. *Reason: Add post of Competition Secretary to the list of Officers and clarify appointment of CDO.* 

#### 7. **Administration** (P40)

A *add* line 2/3: Division Chairs and Secretaries

#### 9. Selection Subcommittees:

B. Para 2. For the selection of inter-county competitions e.g.: Johns Trophy, Middleton Cup, Walker Cup, Balcombe Trophy, Eastern Counties Senior League (not including executive rink) each gender Selection Subcommittee shall appoint a Team Manager and a minimum of two Selectors. Team Managers and Selectors shall not be eligible for selection.

#### 14. Grievances, Discipline and Misconduct: (P42)

A. In the event that there are allegations of misconduct the Association shall adopt the definitions and follow the procedures set out by Bowls England in its Rules and Regulations Rule 9.

D. The rules of natural justice shall apply to all procedures under this rule.

#### 17. Liquidation and Winding Up

#### 18 Alterations of Rules and Constitution

Reason for the renumbering of the rules is that BEFORE Rule 18 all changes have to be approved at an AGM. Thereafter the Rules (renamed BY-LAWS) can be changed after the approval of the Exec.

#### Changes to By-Laws approved by the Executive:

#### **Match By-Laws**

7.c. (Handbook P45)

Male members playing in 5 Eastern Counties League Matches shall be entitled to wear an Eastern Counties Badge immediately below the pocket badge. (*time scale removed*)

## **Dress Code By-Laws**

#### Women

A: Line 3: County Shirt and White/Cream, Dark Blue blazer unless player has a National Blazer.

#### Men:

**A:** Players may if they wish to arrive dressed for match play i.e. County shirt and white or grey trousers but must change into regulation dress with Blazer, collar & tie for the meal and after match formalities. *Add at the end of the existing paragraph*.

## **General for both Match & Competition Play: All Players**: (Page 49)

Reword according to BE clothing regulations including the word "predominantly" when referring to white.

#### Points for Women's County Play (P63)

Para 1 Remove...in the following and subsequent seasons. Reason: Once 16 points has been attained both men and women can apply to play for the County.
